

# Changes to the DCP Clearing Membership Fee Model

ECC will simplify its pricing for the annual DCP Clearing Membership Fees.

With effect from 1 January 2025, ECC will introduce three membership categories for DCP Clearing Members:

Membership Category	Annual Fee
DCP Power Markets Plus	12,500 EUR p.a. or 11,000 GBP p.a.
DCP Discounted Markets Plus	3,500 EUR p.a.
DCP Primary Markets	0 EUR p.a.

The membership categories include participating in clearing of the following markets:

## (1) DCP Power Markets Plus

- Power spot markets (BSP, EPEX SPOT, HUPX, SEMOpX)<sup>1</sup>
- All markets included in the membership category DCP Discounted Markets Plus

<sup>1</sup> DCP Clearing Members in the membership category DCP Power Plus solely participating in clearing of GBP power spot markets will be charged an Annual Fee of 11,000 GBP. All other DCP Clearing Members in the category DCP Power Markets Plus will be charged an Annual Fee of 12,500 EUR.

## (2) DCP Discounted Markets Plus

- EPEX SPOT European Guarantees of Origin Auction
- EPEX SPOT French Capacity Market
- EEX Baltic-Finnish Natural Gas Markets (Lithuania, Latvia-Estonia, and Finland)<sup>2</sup>
- All markets included in the membership category DCP Primary Markets

## (3) DCP Primary Markets

- EEX French Power Guarantees of Origin Auction
- EEX French Biogas Guarantees of Origin Auction
- EEX German National Emissions Trading System (nationales Emissionshandelssystem – nEHS)

The allocation of a DCP Clearing Member to the applicable membership category is based on the markets for which the DCP Clearing Member has been admitted for clearing. The number of Membership IDs used by a DCP Clearing Member does not impact the Annual Fee.
